### ASSESSMENTS OF OWN-SOURCE REVENUES — FAG RELATIVITIES

- 1 Section 3 summarises the assessment results for each category of own-source revenues for the FAG relativities.
- 2 Table 1 shows the average and actual revenues per capita for each category for the five years of the assessment period and the year that dropped out of the assessment period in this update (2001-02).
- 3 Table 2 shows the average and assessed revenues per capita for each category for the six years 2001-02 to 2006-07. Assessed revenues reflect the effect of advantages and/or disadvantages in raising revenue — revenue raising disabilities.
- 4 Table 3 shows revenue raising capacity ratios for each category. Revenue raising capacity ratios compare each State's capacity to raise revenue given its revenue raising disabilities. Revenue raising capacities ratios are the ratio of a State's assessed per capita revenue to the standard revenue. Equivalently, they are the ratio of a State's revenue base per capita to the Australian revenue base per capita. Table 3 also shows the percentage contribution of the average revenue for each category to total own-source revenue, as a guide to the importance of the revenue raising capacity ratios for that category in shaping the overall per capita relativities.
- 5 Table 4 shows implied revenue raising effort ratios. They are the ratio of a State's actual revenue to its assessed revenue. Actual revenues reflect revenue raising disabilities and differences in policies. Abnormal receipts, such as special dividends required of State-owned enterprises, affect the apparent effort of the State that receives them and reduces the apparent effort of other States (because they increase assessed revenues and the average revenue).
- 6 Following the summary tables are the assessment results for the eight categories of own source revenue for which assessments for financial assistance grant (FAG) relativities differ from assessments for GST relativities. The details include:
  - a description of the category;

- a short description of the assessment method;
- the results for 2006-07 and comments on them;
- the contribution of the assessment to the distribution of FAG revenue and health care grants<sup>1</sup>;
- the changes to the assessment since the 2007 Update and their effect on the distribution of FAG revenue; and
- the results for all years of the assessment period.

7 The analysis of the effects of the assessment on FAG revenue distribution uses an illustrative grant pool. The size of the illustrative grant pool changes from one inquiry to the next. To ensure that only the effects of changes in Commission assessments are shown, the analysis measures all grant effects using the 2006-07 pool of FAG revenue and health care grants of \$32 847.9 million from the Commonwealth of Australia's *Mid-Year Economic and Fiscal Outlook*.
