## REVENUE AND EXPENSE RATIOS

- 1 The tables in this chapter show for each year of the assessment period and for each State:
  - the assessed revenue raising capacity ratios for each revenue category;
  - the assessed revenue raising effort ratios for each revenue category;
  - the assessed cost of providing service ratios for each expense category; and
  - the assessed level of service ratios for each expense category.
- 2 An **assessed revenue raising capacity ratio** of a State is the ratio of the State's assessed revenue per capita to the Australian average revenue per capita. The assessed revenue is the revenue the State could have raised from its revenue bases, if it taxed them at Australian average tax rates. A ratio greater than 1.0 indicates that a State has a capacity to raise revenue above the Australian average. A ratio below 1.0 indicates below average capacity.
- 3 An **assessed revenue raising effort ratio** of a State is the ratio of the State's actual revenue per capita to its assessed revenue per capita. A ratio greater than 1.0 indicates that a State is making an effort to raise revenue above the Australian average. A ratio below 1.0 indicates below average effort.
- 4 An **assessed cost of providing services ratio** of a State is the ratio of the State's assessed gross expenses per capita to the Australian average gross expenses per capita. The assessed gross expenses are what the State would have needed to spend to provide the Australian average level of services to its population. A ratio greater than 1.0 indicates that a State faces costs above the Australian average to provide Australian average levels of service. A ratio below 1.0 indicates below average costs.
- 5 An **assessed level of service ratio** of a State is the ratio of the State's estimated gross expenses per capita to its assessed gross expenses per capita. A ratio greater than 1.0 indicates that a State is providing services at levels above the Australian average. A ratio below 1.0 indicates below average levels of service.

- 6 Considerable caution is needed in interpreting the assessed level of service ratios. There are two main reasons for this. First, actual expenses for each State that are used to derive these ratios may not be strictly comparable between States because States sometimes classify similar expenses differently. The second reason is specific to the ACT, where its expenses in some categories may include municipal transactions, thereby making its level of service ratios not directly comparable with those of other States. The Commission is concerned about the comparability of the actual State expense figures for individual categories and will be reviewing whether it continues to publish the assessed level of service ratios.
